- The Board's primary responsibility is to protect the health and safety of Aotearoa
   New Zealand public.
- The Board has a duty under section 14 of the Health Practitioners Competence
   Assurance Act 2003 to ensure scopes of practice are fit for purpose and enable a
   flexible and responsive workforce.
- In 2023, the Board commenced a process to review its scope of practice.
- The Board has not made any decision(s) in relation to this review, and it remains open-minded.

# Why Consider a Change?

- As the Board developed its strategy Hauora for all it identified the need to ensure robust mechanisms are in place
  to protect public safety.
- This includes ensuring scopes of practice are fit for purpose, consistent with the Act, and enable a flexible and responsive workforce in an ever-changing health sector.
- The Board is committed to discharging its responsibility, over time, to ensure future practice remains demonstrably within the legal framework but is open minded about how that will be achieved.



### What Does This Mean For Me?

- Nothing has changed.
- You can continue to do what you are already doing, providing that you have the appropriate qualifications and competence.
- The intent is to ensure that the Board is visibly discharging its responsibility to ensure future practice remains demonstrably within the legal framework.
- You are invited to digest the information, ask more questions, engage in the conversation further and provide more informed and considered feedback.
   The Board will determine at a later date whether there will be a further consultation period.
- Separately, ACC has been considering its approach to its Psychological Services contract. Contract decisions are up to ACC and separate from the Board's review of Scopes of Practice.



### Engagement


- We hear that some people are concerned about what this means for their professional status or ability to work.

# What is the process?


- As we develop our collective thinking and hear further from stakeholders, we remain open-minded. Nothing is off the table and any process as a result of floated options from the advisory group and consultations would be expected to take several years.
- The Board wants to hear from psychologists before making any decisions. Please contribute by the 31 May 2024.
- The Board needs to consider the feedback it receives following this consultation and any potential further consultations. This will occur at a Board meeting.
- An advisory group is being set up to ensure representation across the sector. The purpose of this group will be to review feedback, develop options and a recommendation and provide input into further iterations of any future consultation documents.
- In due course, if the Board decides to make any changes to scopes, it would Gazette the new scopes of practice notice. Once gazetted there would be a time period before it came into effect. The Board will continue to communicate with all practitioners during and following any consultations.
